FIRST QUARTER 2020: GOOD PERFORMANCE DESPITE THE HEALTH CRISIS

Contacts Consulting has been consolidated since February 1st 2019, Océane Consulting Nord since July 1st 2019, Neonn since August 1st 2019 and Ebiznext since December 1st 2019.

Umanis (Euronext Growth - FR0013263878 - ALUMS) achieved a strong 1st quarter 2020, despite the health crisis impact linked to the Covid-19 epidemic and the lockdown measures in force since mid-March.

The group recorded a quarterly consolidated revenue of € 61.2 million, up 10% compared to the first quarter of 2019. ESN business, which totaled 97% of the group's business in 2019, has increased by 11% growth over the quarter.

PROSPECTS

As announced when publishing the 2019 annual results, the consequences of the health crisis remained relatively limited in the 1st quarter, due to the pro rata temporis effect and the high quality performance at the beginning of the year before the crisis appeared.

In addition, Umanis's service center organization model has brought high resilience level for the current climate.

However, the group is expecting a stronger impact on the second quarter compared to last year's business level.

As the present situation is by its nature extremely changing, it is quite difficult at this stage to quantify the consequences on business and more generally on the economic environment for the coming months. In this context, the group has not set financial goals for the 2020 financial year.
